#### Introduction

At **IGETIS**, we take your privacy seriously. This Privacy Policy explains how we collect, use, store, and protect personal and organizational data when you use **IGETIS Keyvault** (the "Service").

#### Data We Collect

When using IGETIS Keyvault, we may collect the following data:

- **Account Information**: Tenant ID, Client ID, and authentication details necessary to access the service.
- **Service Metadata**: Logs and telemetry regarding usage, uptime, and performance.
- Support Requests: Information voluntarily provided when contacting our support team.

**Important**: Secrets, credentials, and cryptographic keys stored within IGETIS Keyvault remain fully encrypted at rest and in transit. **IGETIS cannot access the content of your secrets.** 

### How We Use Data

Collected data is used strictly for:

- Providing and maintaining the Service.
- Improving performance, security, and reliability.
- Responding to support inquiries.
- Meeting legal, security, and compliance obligations.

We **never sell, share, or trade customer data** with third parties for marketing purposes.

## **Data Security**

- Secrets and credentials are encrypted using industry-standard algorithms.
- Data is stored exclusively within Microsoft Azure-compliant environments.
- Multi-Factor Authentication (MFA) can be enabled for enhanced account security.

#### **Data Retention**

- Encrypted secrets remain available as long as your account is active.
- Logs and metadata are retained for a maximum of 90 days for security and audit purposes.
- Upon account termination, all associated data is deleted within **30 days**, unless otherwise required by law.

### **Data Sharing and Compliance**

We may disclose limited information:

- To comply with applicable laws or legal processes.
- To enforce our agreements and policies.
- To protect the security of our systems and customers.

IGETIS complies with GDPR and applicable data protection regulations.

Depending on your jurisdiction, you may have the right to:

- Access, update, or delete your personal data.
- Request a copy of the data we hold.
- Restrict or object to certain processing activities.
